Amy Smith and Nidia Cantu talked about the Texas Advocacy Project's Townhall on the recent 5<sup>th</sup> Court of Appeals ruling in regards to the surrender of guns with a Protective Order. Both Amy and Nidia were a little more hopefully about the outcome of some PO's. TAP was asked to create a 2-minute video to sum up the ruling for agencies. Not sure if that will occur.

Deborah Alexis discussed her new position as the Advocate in the 280<sup>th</sup> Court. She is providing support to the applicants in the Court at the Judge's request. She will provide support, safety information, and resources. She said the new Judge is more neutral and, in the middle, than previous judges. The Judge does not like prewritten statements she prefers to hear things directly from the parties. She also prefers applicants to remember specific dates when the violence occurred. So far things seem to be going well. As of February 1<sup>st</sup>, all P.O.'s are going back to the 280<sup>th</sup>. No news on how that will affect the policies at the D.A.'s Office at this time.

The next meeting is scheduled on the same day as Part 2 of the Immigration training so we will not meet. Our next meeting will be on April 20<sup>th</sup> at 11:30 via ZOOM.
